I. **DESCRIPTION**: Hudson Correctional Facility is a medium security correctional facility located in the City of Hudson in Columbia County. The facility is used as a general confinement facility for male incarcerated individuals 18 years and older. The facility includes a Residential Rehabilitation Unit (RRU) utilized as a disciplinary housing unit as well as reintegration into general population.

On the grounds of the Hudson Correctional Facility is a separate Hudson Work Release Facility. These facilities allow for complete separation from the two distinct populations.

II. FUNCTIONS: Hudson Correctional Facility offers a full range of programs including: academic education, vocational training, substance abuse education and treatment, transitional services, sex offender counseling, and group and individual counseling services. Focus is on family reunification and transition/discharge planning to develop a foundation for positive change.

Hudson Correctional Facility is classified as Mental Health Service Level 1, as defined in Correction Law, Section 2 (27).

The Hudson Work Release Facility houses male incarcerated individuals who meet the placement for the Work Release Program and incarcerated individuals meeting placement criteria for the Industrial Training Program at the Division of Industries in Central Office.

III. CRITERIA

- A. To be eligible for placement into the Hudson Correctional Facility general confinement component, a male must be 18 years or older and have a medium security classification.
- B. To be eligible for placement in Hudson Correctional Facility's temporary release (i.e., Work Release and Industrial Training Leave) component, a male incarcerated individual must:
 - 1. Be statutorily eligible for temporary release.
 - 2. Be within 24 months of parole eligibility, conditional release, or maximum expiration of sentence.
 - 3. Have never been convicted of absconding or escape offenses.
 - 4. Have had no outstanding warrants.
 - 5. Be physically, mentally, and emotionally capable of seeking and maintaining steady, gainful employment.

IV. PHYSICAL ENVIRONMENT

- A. Housing Units within Hudson Correctional Facility general confinement consist of rooms housing no more than two incarcerated individuals.
- B. The RRU operates with single occupancy cells.
- C. Housing Units within the Hudson Work Release Facility consist of dormitories in a building outside of the secure perimeter, housing Work Release and Industrial Training incarcerated individuals.
