ADMISSIONS AND RELEASES CALENDAR YEAR 2020

DOCCS POPULATION: The population in the Department of Corrections and Community Supervision facilities (including incarcerated parolees) dropped by 9,871 incarcerated individuals (-22.3%) from the end of December 2019 to the end of December 2020. The number of individuals in state ready status stood at 903 at the close of December 2020, compared to 242 at the close of December 2019, up 661 (+273.1%). Overall, bedspace demand decreased by 20.7% (-9,210).

Note: During calendar year 2020, DOCCS issued a statewide suspension of intake for approximately 100 days, with an additional 60 day suspension of intake at Elmira Correctional Facility. This suspension resulted in the increase of State Readies and the decrease in Admissions.

ADMISSIONS: Total admissions for CY 2020 at 7,285 were (-59.4%) or 10,679 below the 17,964 recorded during this period in 2019. Court commitments decreased by 6,463 (-62.1%) and admissions for violating parole conditions decreased by 3,019 (-55.3%). There were 622 participants admitted to an Alternative treatment program in 2020, down 1,189 (-65.7%) from 2019. Other admissions decreased by 8 (-2.8%).

*Individuals returned to custody for violating conditions of parole supervision; this includes warrants issued for a new arrest, absconding or a technical violation. Individuals under parole supervision who return to custody for a new felony conviction are included in the Court Commitments admission category.

INCARCERATED PAROLEE ADMISSIONS: Total incarcerated parolee admissions for CY 2020 at 1,116 were 68.6% or 2,438 lower than the 3,554 recorded for CY 2019. Willard Judicially Sanctioned (JS) admissions decreased by 449 (-62.4%) from 2019. Willard Parole Violator (PV) diversions decreased by 581 (-66.4%). There were 114 participants admitted to Edgecombe Residential Treatment in 2020, down 384 (-77.1%) from 2019. There were 438 participants admitted to Parole Diversion and Other Programs during 2020, a decrease of 1,024 (-70.0%) from 2019.

RELEASES: There were 16,649 incarcerated individuals released from DOCCS facilities during CY 2020 which was 4,447 less (-21.1%) than the 21,096 released during 2019. Releases to Community Supervision decreased by 19.6% -3,603 from 18,359 in 2019 to 14,756 in 2020. Parole releases accounted for 6,468 of the CY 2020 releases compared to 8,526 in 2019, down 2,058 (-24.1%). Conditional releases at 6,436 were 598 below the 7,034 in 2019 (-598 conditional releases). There were 898 cases released following participation in the Alternative treatment program, down 715 (-44.3%) from 2019. Releases at maximum expiration of sentence decreased by 740 (-37.6%).

INCARCERATED PAROLEE RELEASES: There were 1,618 incarcerated parolees released from DOCCS facilities during CY 2020, which was 1,990 less (-55.2%) than the 3,608 released in 2019. Willard Judicially Sanctioned releases accounted for 382 of the CY 2020 releases compared to 758 in 2019, down 376 (-49.6%). The number of Willard Parole Violator releases at 479 was 405 less than the 884 in 2019 (-45.8%). The number of parolee participants released from Edgecombe Residential Treatment decreased by 350 (-68.5%). There were 596 parolee participants released from Parole Diversion and Other Programs during 2020, a decrease of 859 (-59.0%) from 2019.
