## ADMISSIONS AND RELEASES CALENDAR YEAR 2019

<u>DOCCS POPULATION:</u> The population in the Department of Corrections and Community Supervision facilities (including incarcerated parolees) dropped by 3,183 incarcerated individuals (-6.7%) from the end of December 2018 to the end of December 2019. The number of individuals in state ready status stood at 242 at the close of December 2019, compared to 226 at the close of December 2018, up 16 (+7.1%). Overall, bedspace demand decreased by 6.6%.

<u>ADMISSIONS:</u> Total admissions for CY 2019 at 17,964 were -7.4% or 1,431 below the 19,395 recorded during this period in 2018. Court commitments decreased by 1,199 (-10.3%) and admissions for violating parole conditions decreased by 388 (-6.6%). There were 1,811 participants admitted to an Alternative Treatment Program in 2019, up 163 (+9.9%) from 2018. Other admissions decreased by 7 (-2.4%).

Individuals under parole supervision who return to custody for a new felony conviction are included in the Court Commitments admission category.

**INCARCERATED PAROLEE ADMISSIONS:** Total incarcerated parolee admissions for CY 2019 at 3,554 were 4.0% or 147 below the 3,701 recorded for CY 2018. Willard Judicially Sanctioned (JS) admissions decreased by 43 (-5.6%) from 2018. Willard Parole Violator (PV) diversions decreased by 46 (-5.0%). There were 498 participants admitted to Edgecombe Residential Treatment in 2019, down 138 (-21.7%) from 2018. There were 1,462 participants admitted to Parole Diversion and Other Programs during 2019, an increase of 80 (+5.8%) from 2018.

<u>RELEASES:</u> There were 21,096 incarcerated individuals released from DOCCS facilities during CY 2019, which was 1,137 less (-5.1%) than the 22,233 released during 2018. Releases to Community Supervision decreased by 5.9% (-1,146) from 19,505 in 2018 to 18,359 in 2019. Parole releases accounted for 8,526 of the CY 2019 releases compared to 8,575 in 2018, down 49 (-0.6%). Conditional releases at 7,034 were 12.0% below the 7,991 in 2018 (-957 conditional releases). There were 1,613 cases released following participation in the Alternative Treatment Program, down 129 (-7.4%) from 2018. Releases at maximum expiration of sentence decreased by 130 (-6.2%).

**INCARCERATED PAROLEE RELEASES:** There were 3,608 incarcerated parolees released from DOCCS facilities during CY 2019, which was 64 less (-1.7%) than the 3,672 released in 2018. Willard Judicially Sanctioned releases accounted for 758 of the CY 2019 releases compared to 735 in 2018, up 23 (+3.1%). The number of Willard Parole Violator releases at 884 was 71 less than the 955 in 2018 (-7.4%). The number of individuals released from Edgecombe Residential Treatment decreased by 129 (-20.2%). There were 1,455 individuals released from Parole Diversion and Other Programs during 2019, an increase of 113 (+8.4%) from 2018.
