**I. DESCRIPTION:** Edgecombe Residential Treatment Facility is classified as a minimum security correctional facility for female incarcerated individuals and male incarcerated individuals 18 years of age and older. Edgecombe Residential Treatment Facility is located in the borough of Manhattan in the City of New York.

Edgecombe Residential Treatment Facility is used for the general confinement of, and as a residential treatment facility for, males.

Edgecombe Residential Treatment Facility is also used as a work release facility for females.

**II. FUNCTION:** Edgecombe Residential Treatment Facility's principal function is to provide a diversion and a re-entry program for incarcerated individuals and parole violators.

Edgecombe Residential Treatment Facility provides comprehensive substance abuse treatment through the collaborative efforts of the NYS Office of Alcohol and Substance Abuse (OASAS) and the Department of Corrections and Community Supervision (DOCCS). Individual and group counseling services are also offered, as well as community referrals upon discharge, to assist with the individual's re-entry plan.

Edgecombe Residential Treatment Facility offers a transitional service to the community and home via work release, day reporting, and community residential treatment programming. Edgecombe Residential Treatment Facility provides incarcerated individuals with work and educational release programs within, or in close proximity to, the communities in which they plan to reside following release. Programs focus around individual and family counseling, and upgrading marketable skills and abilities.

Edgecombe Residential Treatment Facility also retains a limited number of cadre incarcerated individuals for facility work detail.

Edgecombe Residential Treatment Facility is classified as Mental Health Service Level 4, as defined in Correction Law, Section 2 (30). For Work Release, Edgecombe Residential Treatment Facility is classified as Mental Health Service Level 2, as defined in Correction Law, Section 2 (28).

**III. CRITERIA:** Placement at Edgecombe Residential Treatment Facility requires the individual to be a Parole Violator. They must have a history of behavior linked to substance abuse. Female incarcerated individuals must be approved for temporary release.

**IV. PHYSICAL ENVIRONMENT:** Housing units at Edgecombe Residential Treatment Facility consist of multiple occupancy rooms.
