## Addendum 1

### IFB #2022-02 - Vehicle and Pedestrian Gate Service and Preventive Maintenance

The following are official modifications which are hereby incorporated into IFB #2022-02 – Vehicle and Pedestrian Gate Service and Preventive Maintenance. The information contained in this memorandum prevails over the original IFB language for all amendments below. Deleted language appears in strikethrough (“~~xxx~~”) and added language appears in bold (“**xxx**”).

1. Qualification of Bidder (page 16):

The following language, in **bold**, has been added to the above-reference section:

Bidder must maintain a business establishment with adequate inventory of the product offered.

Bidder must have at least two years-experience working on vehicle and pedestrian gate locking systems in a correctional facility.

**Bidders shall be certified to install and service Tymetal equipment/systems and shall be outdoor lock certification by Southern Folger. Prior to the start of work, awarded bidder’s must provide the following information: names and experience levels of all technicians who will perform this work; information on their experience; and type of equipment they serviced. Service organization shall have sufficient staff to maintain systems in satisfactory condition and meet specified response times. Bidders not satisfying the experience requirements will be rejected.**

DOCCS reserves the right to investigate or make any inquiry into the capabilities of any bidder to properly perform under any resultant contract. See “Performance Qualifications,” “Disqualification for Past Performance” and “Employees/Subcontractors/Agents” in Appendix B, Specifications.

2. Method of Award

The following language, in **bold**, has been added to the above-reference section:

Award shall be made by **Grand Total** to the lowest responsive and responsible bidder that can meet the specific requirements as outlined in the Scope of Services.

**Bidders must bid on all regions. If one or more regions are not completed, the bid will not be evaluated.**

3. Bid Price Page

The **Bid Price Page**, found on page 32 of IFB# 2022-02 has been replaced with the attached entitled **Revised Bid Price Page**. Bidders must submit a completed **Revised Bid Price Page** with their bid.
