IFB 2023-02, Electrocardiogram (ECG) Services

The following are official modifications which are hereby incorporated into IFB 2023-02 – Electrocardiogram (ECG) Services. The information contained in this amendment prevails over the original IFB language for all amendments below, deleted language appears in strikethrough (“~~xxx~~”) and added language appears in bold and underline (“xxx”).

Page 15 Price:

Bidders bid price shall be inclusive of all costs including by not necessarily limited to: travel, license, insurance administrative, profit, all labor and equipment costs including three (3) year extended warranty for each new ECG machine (extended warranty must cover all parts, labor, shipping and handling) reporting or other requirements, all overhead costs and other ancillary costs including paper, disposable electrodes, replacement wires, adapter clips, transmission, archival and retrieval of test. Details of service not explicitly stated in these specifications, but necessarily attendant thereto are deemed to be understood by the bidder and included herein. NOTE: Prices must be rounded to the nearest cent.

Page 21 Scope of Services:

7. All ECG machines must be able to transmit test data to a centralized system for interpretation and archival. Transmission capabilities and retrieval of archived test results must be included in the price of the interpretation cost ECG machine. All ECG transmittals and storage must be within the Continental United States.

13. STAT overreads must be faxed ~~faxed~~ back to the requesting facility within thirty (30) minutes along with phone notifications of all critical reads.
