SECTION 1. PURPOSE has been revised as follows for Round 3:

DOCCS seeks to establish Community Based Residential Programs throughout New York State under the following general provisions and designated Catchment Areas:

ANNUAL COST

DOCCS will not consider any application with an annual cost per bed to DOCCS which exceeds:

- \$26,000 in Catchment Areas 6, 7, 10, 11, 12, 13, 14, 15, 16, 17, 18, 19, 20, 21, 22, 23, and 24

OR

- \$29,000 in Catchment Areas 1, 2, 3, 4, 5, 8, and 9

If your proposal annual cost per bed to DOCCS is more than these levels, your application will be disqualified.
