- 1) Section III Key Events/Dates (Page 6) is updated to show Proposals Due to DOCCS no later than October 17, 2024, by 3:00 PM as noted below:

B. Technical Proposal (65%)

1. Table of Organization which includes, but is not limited to:
 - a. Reporting roles and responsibilities in detail.
 - b. A description of how services will be provided.
 - c. Credentials and/or qualifications needed for each staff title.
 - d. Identification of the Medical Director, Nephrologist, ~~Dietician~~, and Social Worker; or recruitment plan/information if not yet known.

3) Section XI. Procurement Rights, G on Page 31 is updated to reflect “60 Days after OSC approval”:

G. Upon contract award, if Contractor is not able to start the program on ~~April 1, 2018~~ 60 Days after OSC approval, DOCCS has the right to withdraw its award. The proposal with the second highest point allocation will then be awarded a contract.

All other terms and conditions remain the same.
