**I. DESCRIPTION:** Fishkill Correctional Facility is classified as a medium security correctional facility and is located in the City of Beacon in Dutchess County. This facility is used as general confinement for males 18 years of age or older.

Fishkill Correctional Facility is also classified as a Work Release and Residential Treatment Facility (RTF - to temporarily house certain releasees in accordance with subdivision 10 of Correction Law, Article 1, Section 73).

Fishkill Correctional Facility has one Special Housing Unit (SHU) and two Residential Rehabilitation Units (RRU).

**II. FUNCTIONS:** Fishkill Correctional Facility offers academic education, vocational training, a college program, substance abuse treatment services, Aggression Replacement Training (ART), Advanced ART, Sex Offender Counseling Treatment Program (SOCTP), Temporary Release Programs, Corcraft Industrial Training, Trauma Addiction Mental Health and Recovery (TAMAR), counseling, and volunteer services. Fishkill Correctional Facility also offers Transitional Services, including “Thinking for a Change” (T4C), Family Reunion Program (FRP), Puppies Behind Bars (PBB), Hospice, and Network Unit.

Fishkill Correctional Facility has an Enhanced Intermediate Care Program (ICP) for individuals designated as Seriously Mentally Ill with known patterns of violence (SMI-V) and a Transitional Intermediate Care Program (TrICP). Fishkill Correctional Facility also has a Residential Crisis Treatment Program (RCTP) consisting of observation cells and dormitory beds.

Fishkill Correctional Facility is classified as Mental Health Service Level 1, as defined in Correction Law Article 1, Section 2 (27).

Fishkill Correctional Facility has a Processing Unit (PRC) that is classified as Mental Health Service Level 1, as defined in Correction Law Article 1, Section 2 (27), for Temporary Release removals.

Fishkill Correctional Facility also has a Regional Medical Unit (RMU) with a Long-Term Care Unit (LTC) and a Unit for the Cognitively Impaired (UCI).

**III. CRITERIA**

- A. To be eligible for placement in general confinement, an incarcerated individual must be classified as medium security or lower.
- B. To be eligible for placement in Work Release, an incarcerated individual must be statutorily eligible for Temporary Release as per Article 26 of the Correction Law.
- C. To be eligible for placement in the RMU or the UCI, an incarcerated individual must be maximum B security classification level or lower.

- D. To be eligible for placement in the S Block SHU or RRU, an incarcerated individual must be maximum A security classification level or lower.
- E. To be eligible for placement in the 21A RRU, an incarcerated individual must be medium security classification level or lower.

**IV. PHYSICAL ENVIRONMENT:** Housing units at Fishkill Correctional Facility consist of dormitories, single rooms, multi-occupancy rooms, single cells, and double cells. The RRU has both single cells and double cells. The SHU has double cells.
