

I. DESCRIPTION: This directive establishes the policy of the Department concerning the ordering of packages and articles from a vendor by incarcerated individuals and their family and friends which will be received through the mail into facility package rooms.

Only packages received directly from a vendor will be permitted, except for up to two non-food packages per calendar year, which may be provided by the family or friends of an incarcerated individual. This directive only lists articles which may be received through the package room. It does not set forth a comprehensive list of all articles that an incarcerated individual may be authorized to have.

III. APPLICABILITY: This directive applies to all incarcerated individuals except as follows:

- A. Package privileges for those assigned to a Special Housing Unit (SHU) are restricted and limited by Directive #4933, "Special Housing Units."
- B. Incarcerated individuals in reception status at the Department's reception/classification facilities will not be allowed to receive packages for 30 days from the date of reception.
- C. Incarcerated individuals will not be allowed to receive packages while "in-transit" (temporarily housed at another facility).
- D. Incarcerated individuals housed in Lakeview Shock Incarceration Facility, Drug Treatment Centers, CASAT, Work Release Facilities, IASAT or Edgecombe Residential Treatment Facility will not be allowed to receive packages except as may be specifically authorized and limited by the Deputy Commissioner for Correctional Facilities.

IV. POLICY

- A. General
 1. The Commissioner may, at their discretion, suspend all or any portion of this directive at any or all facilities.

2. This directive lists articles which may be received from vendors, and up to two non-food packages per calendar year from family and friends of an incarcerated individual, through the package room. Books, magazines, and periodicals may also be received from licensed charities and *bona fide* religious organizations. No other articles may be received unless expressly authorized by the Deputy Commissioner for Correctional Facilities in accordance with subsection V-A-2. No changes shall be made in the application of the provisions of this directive without the express authorization of the Deputy Commissioner for Correctional Facilities.
3. Articles received in a package that are not for the incarcerated individual's personal use or which cause the incarcerated individual recipient to exceed in-cell limits as determined by this directive and Directive #4913, "Incarcerated Individual Property," will not be allowed. When an incarcerated individual signs for a package, they will attest (a) that the articles are only for personal use, and (b) that receipt will not cause the incarcerated individual to exceed personal property limits (see Attachment A for a listing of allowable property). If an incarcerated individual refuses to sign for a package, it will be disposed of in accordance with Directive #4913.
4. For the purposes of this directive, the value of an article shall be the actual purchase price, not including any tax, or shipping and handling.
5. An article received by an incarcerated individual under any previous version of this directive but not listed as allowable under this version may be retained by that incarcerated individual for only as long as the incarcerated individual remains at their current facility, except as provided below. A disallowed article must be disposed of prior to transfer in accordance with Directive #4913. Such article may not be given to or transferred to another incarcerated individual.

An incarcerated individual will be permitted to retain electronic devices received under a previous version of this directive (i.e., without clear cases) if transferred to a new facility but may not transfer ownership to another incarcerated individual under any circumstances.
6. Where an article received under this or any previous version of this directive is subsequently declared prohibited by order of the Deputy Commissioner for Correctional Facilities, it must be disposed of in accordance with Directive #4913. There shall be a three-month grace period for articles in an incarcerated individual's possession which subsequently become prohibited, unless otherwise specified by the Deputy Commissioner for Correctional Facilities. However, if the prohibited article represents a threat to the safety or security of the institution, the incarcerated individual shall be required to dispose of it immediately. In no case shall an incarcerated individual be allowed to possess a prohibited article upon transfer to another facility.
7. The Department is not responsible for articles damaged in shipping or received in spoiled condition. Spoiled food articles, or items which are contaminated or in broken or leaking containers are considered a health risk and will be destroyed by the facility. Such destruction will be recorded on the incarcerated individual's package records ([Form #1755](#), "Non-Food Package Record," and [Form #1755F](#), "Food Package Record").
8. All return-to-sender packages must be recorded on [Form #1755](#), and in the "Department System for Tracking Incarcerated Individual Packages & Visits" (KVPR) System.

9. There shall be no exchange of funds or packages between incarcerated individuals, except as authorized in Directive #4761, "Incarcerated Individual Charitable Contributions and Gifts."
10. Excluding weekends and holidays, or emergency situations, incoming packages are held for no more than 72 hours. This does not prohibit the withholding of packages for incarcerated individuals temporarily absent from the facility as set forth in subsection IV-K-2.
11. Items (except for jewelry) designated as gender specific (male only or female only) may be received by an incarcerated individual whose gender identity on record with the Department is consistent with the specified gender, regardless of the gender classification of the facility where they are being housed. As such, female only items will be permitted for transgender females and male only items will be permitted for transgender males. Gender nonconforming, gender nonbinary, individuals with a gender dysphoria diagnosis, and intersex individuals may receive items approved for either males or females. Certain items as indicated in this directive will require a medical permit.

NOTE: The State considers gender dysphoria a disability, any incarcerated individual diagnosed with gender dysphoria can file a reasonable accommodation to access clothing for both sexes in accordance with Directive #2614, "Reasonable Accommodations for Incarcerated Individuals with Disabilities."

B. Searches of Packages

1. Packages shall be searched thoroughly to ensure that all articles conform to regulations. Articles will be removed from the original shipping container (box or bag in which the package was shipped to the facility) and inspected visually and by use of the x-ray machine. In searching and examining packages, care shall be taken not to damage or destroy the contents. The shipping container (bag or box) will not be given to the incarcerated individual.
2. Absent security concerns, the original product packaging will not be opened or removed. If there are security concerns (e.g., if abnormalities are detected in x-rays, packaging, feel or texture, weight, labeling, etc.), then the contents of individual articles may be removed from the originally sealed packaging for the inspection process. Food articles may be transferred to clear plastic bags or other appropriate containers. In the event an individual article is removed from the originally sealed packaging due to a security concern, the processing officer will prepare a memorandum detailing the reasoning for removal. The original memo will be placed in the incarcerated individual's package room file with a copy sent to the Deputy Superintendent for Security (DSS).
3. Absent security concerns, the original labels that show product information (e.g., expiration date, ingredients, warranty, quantity, etc.) shall be preserved with their related products. In the event original labels are withheld due to a security concern, the processing officer will prepare a memorandum detailing the reasoning for removal. The original memo will be placed in the incarcerated individual's package room file with a copy sent to the DSS.
4. Any correspondence, photos, cash, or money orders included in the package will be forwarded to the appropriate area (i.e., mailroom, business office) to be processed in accordance with Directive #4422, "Incarcerated Individual Correspondence Program," and Directive #2798, "Incarcerated Individual Accounts."

Package room staff will list the items (i.e., correspondence, photos, money orders, cash) on the incarcerated individual's [Form #1755](#) or [Form #1755F](#), indicating the transfer to the appropriate area. A receipt, Form #2702, "Mail Receipt Book," for all cash and money orders will be issued by package room staff.

The receipt number will be recorded on the incarcerated individual's [Form #1755](#) or [Form #1755F](#). All cash receipts are to be handled in accordance with the Office of the State Comptroller (OSC) Guide to Financial Operations.

Promotional materials (e.g., prizes, informational discs, etc.) or other non-product items or substances sealed within original packaging or attached to an allowed article will be removed prior to issue. These materials will be disposed of in accordance with Directive #4913.

5. Inspection and processing of religious articles shall be conducted in such a manner as to respect their religious significance. If an article's religious significance is in doubt, the facility chaplain shall be consulted. If an article is suspected of being contraband, it may be tested as appropriate. Articles which are considered or suspected of being contraband, or which are under evaluation for authenticity or religious significance, shall be secured by the DSS pending disposition and notification of the affected incarcerated individual. If the incarcerated individual files a grievance within 21 days of receipt of a notice that an article has been denied, such religious article shall be retained by the facility pending the final resolution and closing of the grievance.
6. Contraband: Contraband articles shall be confiscated, and the Superintendent or designee notified. Contraband will include any article:
 - a. Which possession of is prohibited under any law applicable to the general public.
 - b. Which is readily capable of being used to cause death or serious physical injury, including but not limited to handguns, shoulder guns, cartridges, knives, explosives, intoxicants, or dangerous drugs (e.g., narcotics).
 - c. Which could be utilized to assist or affect an escape or undermine the safety and security and/or practices consistent with the Department mission, such as unauthorized electronic devices (e.g., cellular telephones, etc.).
 - d. Which has been introduced into a correctional facility with the intent to transfer it to an incarcerated individual without the permission of the Superintendent or their designee.
 - e. Which is an approved item, but it has been altered from its original intent and/or purpose.
7. Articles not permitted (other than contraband)

In the case of articles not permitted for general confinement incarcerated individuals (non-restricted incarcerated individuals), the incarcerated individual will be given the opportunity to view the disallowed article and then choose a disposal option by signing Form #2068, "Authorization for Disposal of Personal Property." If the choice is to ship the article, the incarcerated individual will fill out a disbursement form for the cost of the shipping. The package room will send out the package and forward the disbursement form to the business office for processing. If funds are available, the facility business office will deduct the amount of the disbursement from the incarcerated individual's account.

If funds are not available, the business office will establish an encumbrance for the amount of the disbursement. Items sent out via visitor will be held a maximum of 14 days pending arrival of a visitor. A second choice for disposition should be made in case a visitor does not come or accept the item(s).

- a. Articles not disposed of within 14 days, will be destroyed or donated to a charity by the facility. It is clearly not the Department's intent to give each incarcerated individual 14 days to choose a disposal option, requiring storage by the facility. It is the intent that an incarcerated individual be given a clear notice that an article is not permitted and a clear opportunity to choose how such an article will be disposed of.
8. Articles will not be altered or modified by the manufacturer or vendor, except for removal of external radio antennas. Articles will not be altered or modified once they arrive at the facility in order to comply with the specifications set forth in this directive.
9. If an item is not listed as allowable in Attachment A, the item will not be issued to the incarcerated individual and the decision to withhold it is not reviewable under this directive. However, if an item is listed as allowable but was not issued because, in the opinion of processing staff, it did not meet applicable specifications regarding size, cost, ingredients, property limits, color, etc., the incarcerated individual may request a review of that decision.

The incarcerated individual must first complete Form #2068 and a disbursement form, if appropriate, identifying the item to be reviewed and the disposal option desired. The area supervisor shall then review the item in question during the course of scheduled rounds. The incarcerated individual's presence is not required. Upon completion of the review, the supervisor shall sign and date Form #2068 and indicate whether the item is to be allowed and issued to the incarcerated individual, or disallowed and processed for disposal. A copy of the completed Form #2068 will then be forwarded to the incarcerated individual.

NOTE: If the incarcerated individual refuses to complete and sign Form #2068, no review will be conducted and the item will be disposed of as disallowed property in accordance with Directive #4913.

C. Donation (Charitable Organization)

1. It is the responsibility of the incarcerated individual to provide the name and address of the *bona fide* charity in Section 2 of Form #2068. Failure to do so will be considered a refusal to fully complete Form #2068 and disposition of the items will be at the discretion of the "DSS/First Deputy Superintendent (FDS)/Superintendent (SUPT)" as outlined in Section 6 of the form.
2. Any shipping costs associated with donating the excess personal property or disallowed package items will be the responsibility of the incarcerated individual. If the incarcerated individual has insufficient funds, the disposition of the items will be at the discretion of the "DSS/FDS/SUPT" as outlined in Section 6 of Form #2068.
3. If the charitable organization is determined not to be a *bona fide* charity, the disposition of the items will be at the discretion of the "DSS/FDS/SUPT" as outlined in Section 6 of Form #2068.
4. If the charitable organization refuses to accept the items, the disposition of the items will be at the discretion of the "DSS/FDS/SUPT" as outlined in Section 6 of Form #2068.

- D. Food Packages: Incarcerated individuals may receive three packages a month containing foodstuffs from a vendor, as listed in Attachment A, the combined weight of which shall not exceed 40 pounds. The three packages a month are based on when they are received at the facility, not when they are ordered.
- Incarcerated individuals, friends, and/or family members ordering food packages from vendors who serve as third party fulfillment services, must pay special attention, as these companies may split orders when shipping, causing the incarcerated individual to exceed the number of monthly allowable food packages. Food packages exceeding the established limit will be denied.
- E. Personal Release Clothing: Incarcerated individuals wishing to wear personal release clothing, may receive such items directly from family and/or friends no earlier than two weeks prior to their scheduled release date, but in any event, no later than 72 hours prior to same.
- NOTE: No cellphones, smart watches, or similar items are allowed.
- F. Packages from Vendors Received by Mail (U.S. Postal Service, UPS, FedEx, etc.)
1. Incoming
 - a. An incarcerated individual may receive a package through the mail from any vendor that is not on the disapproved vendor list. The package must bear the incarcerated individual's name and Department Identification Number (DIN) on the packaging.
 - b. A package from a vendor must bear the return address as affixed or printed (not handwritten) by the vendor or it will not be delivered to the incarcerated individual. The unopened package, with no return address or insufficient return address will be first x-rayed for contraband. The package will then be opened. If any contraband is found, it will be processed in accordance with Directive #4910A, "Contraband/Evidence – Handling, Storage, and Disposition," and any remaining contents disposed of as directed by the DSS. If no contraband is found, the incarcerated individual will be given the option to send the package out at their expense or to have it destroyed. In all cases, the disposition of the package will be recorded on Form #2068 and the incarcerated individual's package record.

NOTE: If a vendor attempts to transmit contraband within a package, such matters must be reported by the Deputy Superintendent for Administration (DSA) to Support Operations via Form SOPVDR, "Incarcerated Individual Package Vendor Disapproval Request Form," to request addition to the disapproved vendor list.
 2. Outgoing
 - a. All packages sent from a facility at an incarcerated individual's request, including surplus, non-allowed, or transferred articles, shall be processed through the package room. All expenses shall be borne by the incarcerated individual.
 - b. All packages sent from a facility shall be receipted by the carrier. If a receipted carrier is not used, the incarcerated individual must insure the package in order to get a receipt.
 - c. The incarcerated individual may also be required to pay for a shipping container approved by the U.S. Postal Service.

- d. Articles which require repair or service may only be sent to a vendor or business which is not on the disapproved vendor list, and which is recognized as providing the needed repair or service. Repairs and service will not be done in the facility except where authorized by the Superintendent (e.g., at a State-run repair shop) and strictly controlled.
- e. An incarcerated individual wishing to send a package or gift to a relative incarcerated in another Department facility must obtain authorization from their assigned Offender Rehabilitation Coordinator (ORC) and approval of the facility Superintendent, contingent upon agreement by the receiving facility Superintendent.

NOTE: The transfer of funds and art and craft products between incarcerated individuals is governed by Directive #4761.

- 3. Art and Handicraft Supplies: Art and handicraft supplies may only be received through a facility package room from a vendor. Such materials will only be admitted under local permit and made available for the incarcerated individual's use in their living quarters or other areas designated by the facility Superintendent.

NOTE: The policies and procedures for shipping and receiving incarcerated individual tablets are outlined in Directive #4425, "Incarcerated Individual Tablet Program."

- G. Packages Directly From Family and Friends by Mail (U.S. Postal Service, UPS, FedEx, etc.): An incarcerated individual may receive up to two non-food packages per calendar year from family and friends by mail. The package must bear the incarcerated individual's name and DIN on the packaging. The package must also bear a return address that includes the sender's first and last name.

H. Package Records

- 1. All articles received shall be recorded on [Forms #1755](#) and [Form #1755F](#), with the sender's name and address and the name and DIN of the incarcerated individual recipient.
- 2. The incarcerated individual shall sign Departmental [Form #1755V](#), "Received Value Record," listing any single article received which has a verified value of more than \$30.00. Any article priced or valued at over \$30.00 must be accompanied by the vendor's original receipt, bill, or invoice. The original receipt, bill, or invoice must be printed, handwritten will not be accepted. A copy of [Form #1755V](#) will be filed in the package room folder and a copy given to the incarcerated individual. These articles include, but are not limited to, the following:

Art and handicraft supplies	Hair dryer/blow dryer/curling iron
Authorized religious apparel	Footwear
Audio equipment	Jewelry
Blanket	Musical instruments
Calculator	Rug/prayer rug
Clothing articles	Sunglasses
Electric shaver/razor	Typewriter
Electronic devices	Watch & Watch band
Gloves (baseball mitt, handball, bag)	

3. A current listing of “local permits” issued per Section V shall be maintained by the facility in the package room.
4. Special Watch Notations: A notation shall be made on an incarcerated individual’s package room record if:
 - a. A sender to that incarcerated individual attempts to transmit contraband within a package.
 - b. An incarcerated individual has been found in possession of contraband that was determined to have been received within a package.
 - c. An incarcerated individual has been found guilty of drug-related misbehavior.

These notations shall alert staff to take appropriate precautions to prevent smuggling of drugs, drug paraphernalia, or other contraband in subsequent packages. However, any notations which correspond to disciplinary proceedings against an incarcerated individual, but which are later dismissed or reversed must be expunged from the incarcerated individual’s package room records.

I. Loss of Package Privileges

1. Packages received for an incarcerated individual serving a disciplinary disposition which includes “loss of package privileges” will be handled as follows:
 - a. From a Publisher – shall be given to the incarcerated individual subject to the provisions of Directive #4572, “Media Review.”
 - b. From a Vendor
 - (1) If ordered by the incarcerated individual, and approved by the business office prior to the disciplinary disposition, the package shall be issued to the incarcerated individual, otherwise, the package shall be returned to sender.
 - (2) If ordered by family or a correspondent, the package shall be handled as set forth in subsection IV-I-1-b-(3).
 - (3) From All Other Sources
 - (a) If received during the first five days of “loss of packages,” they shall be delivered to the incarcerated individual unless they have been confined in a SHU.
 - (b) If received after the first five days of “loss of packages,” they shall be returned to sender unopened.
2. An incarcerated individual who orders a package while under a loss of package disposition will have the package returned to sender and will be responsible for any expense associated with return of the package.

J. Packages Received for Incarcerated Individuals in a Special Housing Unit (SHU)

1. Pending disciplinary action, or during first five days of a “loss of packages” disposition:

Package items, except for books, periodicals, legal materials and perishables, shall be placed in the incarcerated individual’s property, and added to the incarcerated individual’s property inventory on [Form #2064](#), “Personal Property Transferred,” books, periodicals, and legal materials may be given to the incarcerated individual subject to the limitations in Directive #4933, but perishables shall be disposed of in accordance with Directive #4913.

2. Serving a disciplinary disposition, or after the first five days of a “loss of packages” disposition: The incarcerated individual will be afforded package privileges in accordance with Directive #4933.

K. Packages Received for Incarcerated Individuals Transferred or Temporarily Absent from the Facility

1. Transfer

- a. During processing for transfer, the incarcerated individual will be directed to indicate on [Form #2064](#) whether they will pay for postage to forward any package received within 14 days at the sending facility. If the incarcerated individual elects to pay for package forwarding, they shall also sign a disbursement form marked “Postage Due.” If the incarcerated individual fails or refuses to indicate their choice or hasn’t signed a disbursement form, packages received will be returned to sender.
- b. The goldenrod copy of [Form #2064](#) and signed disbursement form shall be maintained in a file at the sending facility. Whenever a package is received for an incarcerated individual no longer at the facility, package room staff shall check [Form #2064](#) to determine the incarcerated individual’s choice.
- c. Any package received after 14 days from the incarcerated individual’s date of transfer will be returned to sender. Where a package is received within 14 days and the incarcerated individual has indicated that they will pay forwarding postage and has signed a disbursement form, the shipping facility will absorb the cost of shipping from its postage appropriation and ship the package, and send a copy of the incarcerated individual’s [Form #2064](#) and the signed disbursement form to the business office at the incarcerated individual’s new facility.
- d. Upon receipt at the incarcerated individual’s new facility, the forwarded package will be issued in accordance with the provisions of this directive. If funds are not available to process the disbursement, the incarcerated individual’s account will be encumbered for the owed amount. When any encumbrance is fully collected, the collecting facility will use the funds collected to refund its own postage appropriation.
- e. Packages must not be forwarded to incarcerated individuals at Work Release facilities but returned to sender.

2. Temporary absence (out-to-court, or hospital, or in-transit to another facility)

- a. A package for an incarcerated individual who is temporarily absent shall be x-rayed. If the package contains perishables, it shall be returned to sender. If no perishables are found, the package shall be stored by the facility unless it is determined that the incarcerated individual is likely to be absent in excess of 14 days.
- b. Where the incarcerated individual is expected to be or has already been absent in excess of 14 days, the matter shall be referred to the DSS to determine if the package should be held longer or returned to sender.

V. LOCAL PERMITS

- A. Certain articles cannot be approved Department wide because of programmatic and physical plant characteristics of individual facilities. In order that those locations which can accommodate special articles are not governed by those which cannot, each facility may consider the issuance of “local permits” in accordance with the following:

1. Local permits for articles so marked and listed in this directive require the approval of the facility Superintendent, but do not require the approval of the Deputy Commissioner for Correctional Facilities.
 2. Local permits for articles not listed in this directive require the recommendation of the facility Superintendent and the approval of the Deputy Commissioner for Correctional Facilities. Such recommendations shall include:
 - a. Identification of the article for which a local permit is recommended.
 - b. The Superintendent's rationale for the recommendation.
 - c. Specific terms and conditions regarding the use of the article as prescribed in subsection V-A-5.
 3. Any article approved by local permit shall be clearly identified by mark or label and a record of such identification maintained by the facility. The original permit shall be maintained in the incarcerated individual's package records and a copy given to the incarcerated individual. The incarcerated individual must retain their copy of the permit to protect the privilege of retaining this article.
 4. By signing the local permit, the incarcerated individual shall indicate their understanding that the permit is valid only in their current facility and, in the event that they are transferred and cannot obtain a local permit for the article at their subsequent location, the article must be disposed of at the incarcerated individual's expense.
 5. The local permit shall specify the terms and conditions regarding the use of the article (with respect to program and periods or locations in which the article may be used) and indicate that failure to adhere to such terms and conditions may result in the revocation of the permit. If a permit is revoked, the article will be confiscated and disposed of at the incarcerated individual's expense in accordance with Directive #4913. The incarcerated individual's signature shall indicate their agreement with these terms and conditions. If the incarcerated individual refuses to sign the permit, the permit shall not be granted.
- B. Each Superintendent is required to maintain a current list of all approved local permits to include:
1. Identification of incarcerated individual.
 2. Identification of the article.
 3. Identification of the approving authority.
 4. Date of approval by the Deputy Commissioner for Correctional Facilities.

VI. ALLOWABLE ARTICLES: Attachment A identifies the only articles which may be allowed through facility package rooms. Articles will only be accepted through the package room, subject to the conditions and restrictions set forth in this directive and specified on each article listing.

Conditions and restrictions set forth on the attached lists cover sources, content ingredients, packaging, quantities, colors, sizes, composition, cost or value, etc., and whether a local permit is required. All articles must be new (unused), except for non-electronic musical instruments, books, magazines, and periodicals, and not exceed the price or value limits set forth for various articles on the attached lists.

VII. INCARCERATED INDIVIDUAL PERSONAL PROPERTY CLAIM FOR PACKAGES

All incarcerated individual personal property claims for packages mailed to a facility will be processed in accordance with Directive #2733, "Incarcerated Individual Personal Property Claim." Claims may only be submitted by an incarcerated individual for packages that have been documented as delivered to the facility.

The attached lists identify the only articles which may be allowed through facility package rooms.

Articles will only be accepted through the package room subject to the conditions and restrictions set forth in this directive and specified on each article listing.

Conditions and restrictions set forth on the attached lists cover sources, content ingredients, packaging, quantities, colors, sizes, composition, cost or value, etc., and whether a local permit is required.

All articles must not exceed the price or value limits set forth for various articles on the attached lists.

All articles must be new (unused), except for non-electronic musical instruments, books, magazines, and periodicals.

- Peppers or hot sauce not to exceed 3600 Scoville Units.
- No foods containing hot peppers (whole or pieces).

Packaging

- No glass containers or cans.
- Items, except for fresh fruits and vegetables, must be received commercially packaged in airtight hermetically sealed containers impervious to external influence (i.e., heat sealed plastic bags, and vacuum sealed pouches). Containers with paper, plastic, or foil seals are not allowed (e.g., tubular potato chip container, powdered drink mix container wrapped with plastic seal, or coffee creamer plastic jar with a paper or foil seal). A food item contained within a commercially packaged glued outer paper or cardboard box does not, standing alone, make the item disallowed, if the item inside the box is further commercially packaged in a heat-sealed plastic bag. Resealable packaging is permitted.
- All items must have a commercially printed ingredients list on the packaging.
